It is apparent that our club has an emphasis on midweek rides whereas the above clubs limit their rides to the weekend. Therefore it could be argued that they would complement our rides and we need to develop relationships with the clubs accordingly. Ride Group Covid Requirements.

A communication from Patrick McCollough was received by DR and discussed: his points centred on a closed group of 6 led by Martin Vinson of which he was a member. He was concerned at the lack of social distancing and the use of shared locks. It was agreed that we should encourage open groups to offer variety of rides.
