

WSCC 2021 AGM Invitation from the Chairman (Website version)

As previously advertised, the WSCC AGM is to take place as a (virtual) Zoom meeting at 5pm on Saturday 8 May. We hope that as many other club members as possible will be able to join.

Zoom meeting logistics

For confidentiality reasons the link to the meeting has been removed from this website version of the AGM invitation. Members have already received an invitation by email from me which included the link.

I'm sure that you will be familiar with Zoom meetings by now, but if you are unsure how to join, or need assistance, please get in touch in advance with John Child, Laurie Mutch or me and we will do our best to ensure you can gain access. (A 10-minute YouTube video on the basic functions of Zoom can be accessed at https://www.youtube.com/watch?v=ygZ96J_z4AY)

Laurie is acting as host to the Zoom meeting and will be in charge of the technology on the day. To ensure the main speakers are audible, we ask that everyone engages the "mute" function on their screen at all times unless you are addressing the meeting. This can normally be located in the bottom left hand corner of your zoom screen if you hover over the screen with your mouse/finger.

For those wishing to make an intervention, there are two main options:

- You can either use the "Raise Hand" icon that can be found on the Zoom screen. This icon (along with some other options) can be found by clicking the "Reactions" virtual button at the bottom of your zoom screen. You will then be un-muted and invited to speak.
- Or you can type a text message to the meeting by using the virtual "Chat" button at the bottom of your zoom screen. We will monitor and endeavour to respond to any chats as the meeting progresses.

It is possible to see who else is at the meeting by clicking the "Participants" virtual button at the bottom of your zoom screen.

I don't anticipate that the meeting will run much beyond an hour, though that does depend on the technology working smoothly, and on the number of questions and comments we receive.
